#### **Summary of the Lectures:**

Topic: he Malay Diaspora in Europe

There were five main subtopics had been discussed, these were:

- 1. What is Diaspora? Meaning and concept
- 2. Malay diaspora in Europe.
- 3. Malay identities across boundaries
- 4. Why do Malays migrate to Europe?
- 5. Potential positive impacts of Malay diaspora on homeland development

#### **Concept and Definitions:**

Diaspora communities are important agents of development. Their economic and social contribution to developing countries is extensive and diverse. Many are active contributors through remittances and, more recently, through business and volunteering. Diasporas also contribute to international development through their membership in faith organisations, by giving financial donations or volunteering their time.

#### **Diaspora Key Takeaways**

- A diaspora is a group of people who have been forced from or chosen to leave their homeland to settle in other lands.
- People of a diaspora typically preserve and celebrate the culture and traditions of their homeland.
- Diaspora may be created by voluntary emigration or by force, as in the cases of wars, enslavement, or natural disasters.

The key components of this classical diaspora paradigm are:

- 1) Dispersal from a homeland;
- 2) Collective memory of the homeland;
- 3) lack of integration in the host country;
- 4) A 'myth' of return and a persistent link with the homeland.

#### **Importance of Diasporas**

An analytical concept:

History of human experience: dispersion, identity, longing, and return

#### A practical concept:

Of interest to states – political, economic, or cultural mobilization International organizations – development International relations

#### **Elements of Diaspora**

Focus on are homeland, dislocation, displacement, a feeling of Loss, alienation and cultural identity and ethnicity.

#### **Types of Diaspora**

Two kinds of diaspora: forced and voluntary. Forced diaspora often arises from traumatic events such as wars, imperialistic conquest, or enslavement, or from natural disasters like famine or extended drought. As a result, the people of a forced diaspora typically share feelings of persecution, loss, and desire to return to their homeland. In contrast, a voluntary diaspora is a community of people who have left their homelands in search of economic opportunity, as in the massive emigration of people from depressed regions of Europe to the United States

#### Malay Diaspora in Europe

#### **Malay Identities across Boundaries**

People who call themselves Malay - Melayu - are found in many countries, united by a notional shared identity but divided by political boundaries, divergent histories, variant dialects and peculiarities of local experience. While the term 'Malay' is widely used and readily understood in Southeast Asia, it remains elusive and open to varying interpretations. "Malay" as an identity, or

nationality, is one of the most challenging and perplexing concepts in the multi-ethnic world of Southeast Asia. How Malays have identified themselves in time and place, developed by a wide range of scholars.

#### Potential positive impact of Diaspora on development of homeland

Household/extended family sphere: The household sphere refers to all developmental activities undertaken by the diaspora that are organised through kin networks. This includes both the everyday routines of diaspora life, such as the sending of remittances to family and friends at home, and also the involvement with more exceptional life course events such as weddings and funerals

*Known community sphere:* The known community sphere describes social contacts beyond kin, but which do involve personal contacts.

The imagined community sphere: The imagined community sphere refers to those activities which engage members of the diaspora beyond immediate circles of acquaintance. In this sphere the individuals who are engaged in development activities may not even meet each other, but can still participate in some kind of shared project or programme. Typically, this can be illustrated by reference to a nation.

#### **Conclusion**

Diasporas can play an important role in the economic development of their countries of origin. Beyond their well-known role as senders of remittances, Diasporas can also promote trade and foreign direct investment, create businesses and spur entrepreneurship, and transfer new knowledge and skills.

#### **Expected Learning outcomes**

Upon completion of the course students expected to:

- (1) Identify and describe main definitions of the concept "Diaspora".
- (2) Describe and compare main theories and concepts adopted by Diaspora Studies, identify and discuss advantages and disadvantages of main approaches in studying Diasporas;
- (3) Students able to express their innovative ideas and critical thinking in English language and have firsthand interactions with foreign lecturer from European university.

(4)Most importantly, when learning with people from a variety of backgrounds and cultures present in the classroom, students gain a more comprehensive understanding of the subject matter. It also teaches students how to use their own strengths and points of view to contribute in a diverse working environment. Therefore students able to develop their creative thinking and ideas to suit with global issues.
